Older Population (Aged 70 & Above)

As our population ages, an evaluation of motor vehicle incidents involving the elderly is of increasing interest.

Older adults aged 70 and above were involved in 35,660 (8.2%) of all 437,289 crashes that occurred in Illinois in 2003 as drivers, passengers, or non-occupants of vehicles such as pedestrians and pedalcyclists. They represent 207 (14.2%) of all 1,454 traffic fatalities in Illinois in 2003. Just 4.8% of drivers in all crashes were older adults, but 9.2% of drivers in fatal crashes and 13.4% of fatally injured drivers were older adults.*

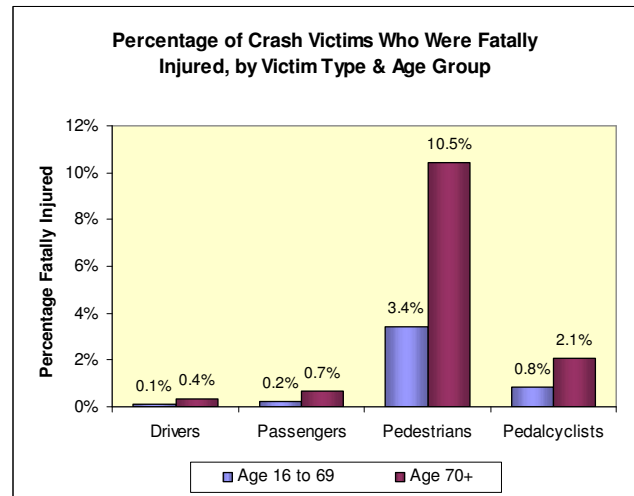

Vulnerability

- Among adults, percent fatalities for drivers, passengers, pedestrians and pedalcyclists all followed similar trends, with percent fatalities increasing as age advanced.
- Overall, older adults who were involved in crashes in Illinois in 2003 in any capacity (driver, passenger or non-occupant) were 3.4 times more likely to be fatally injured than people aged 16 to 69*

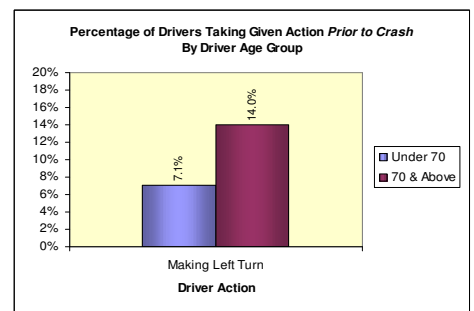
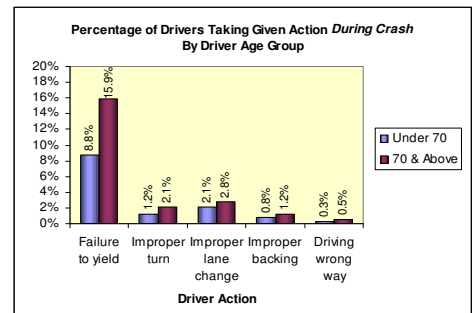
Seat Belt Use

- 27,123 (84.4%)[†] of all 32,137 older drivers of passenger cars/light trucks[‡] reported using seat belts
 - In comparison, 497,096 (82.1%) of all 605,372 younger drivers (aged 16 to 69) of passenger cars/light trucks reported using seat belts
- 6,532 (87.6%)[†] of all 7,456 older passengers of passenger cars/light trucks[‡] reported using seat belts
 - In comparison, 95,004 (83.5%) of all 113,767 younger passengers (aged 16 to 69) of passenger cars/light trucks reported using seat belts

Older Drivers

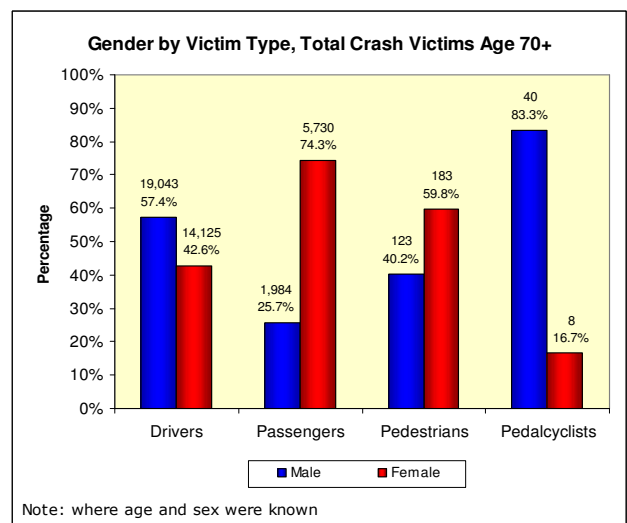
Driving errors and other actions taken by older drivers aged 70 and above before and during crashes tend to be different than those taken by younger drivers.

- Older drivers who were involved in crashes were 1.9 times more likely than younger drivers to have made driving errors such as those shown at right
 - Together, these errors account for 22.6% of older drivers' actions during crashes.
- Older drivers who were involved in crashes were also 1.9 times more likely than other drivers to have been making a left turn prior to the crash, whether or not it was classified by police as an improper turn.
- Where data were known, 16,837 (52.4%) of all 31,979 crashes involving older drivers were intersection-related, compared with 159,576 (39.4%) of all 405,310 crashes in which no older driver was involved
- Where data were known, 2,092 (6.5%) of all 31,979 crashes involving older drivers were speeding-related, compared with 45,532 (11.2%) of all 405,310 crashes in which no older driver was involved
- Where collision type was known, 2,948 (9.2%) of all 31,964 crashes involving older drivers were single vehicle crashes, compared with 87,612 (21.6%) of all 405,104 crashes in which no older driver was involved.



Demographic Facts[§]

- 19,043 (57.4%) of all 33,168 older drivers involved in crashes were male, compared with 389,453 (59.2%) of all 658,229 younger drivers
- 1,984 (25.7%) of all 7,714 older passengers involved in crashes were male, compared with 96,338 (47.1%) of all 204,719 younger passengers
- 123 (40.2%) of all 306 older pedestrians involved in crashes were male, compared with 3,471 (59.2%) of all 5,867 younger pedestrians
- 40 (83.3%) of all 48 older pedalcyclists involved in crashes were male, compared with 2,480 (78.8%) of all 3,148 younger pedalcyclists



[†] Percent using seat belts was defined as the number of people for whom seat belt use was reported divided by the total number of people involved in crashes.

[‡] Passenger cars and light trucks for this analysis were defined as passenger cars, pickup trucks, vans, minivans and SUV's according to classifications used by the National Highway Traffic Safety Administration.

Geographic Facts

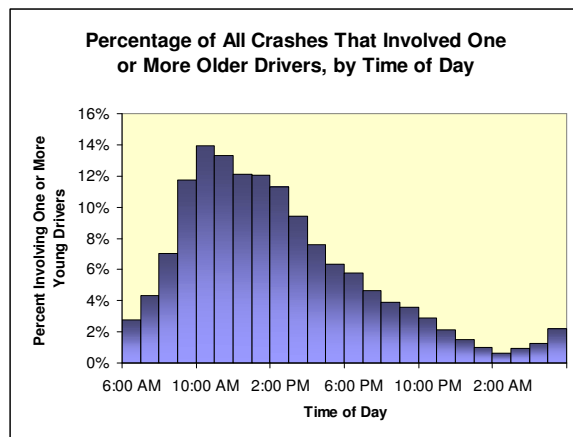
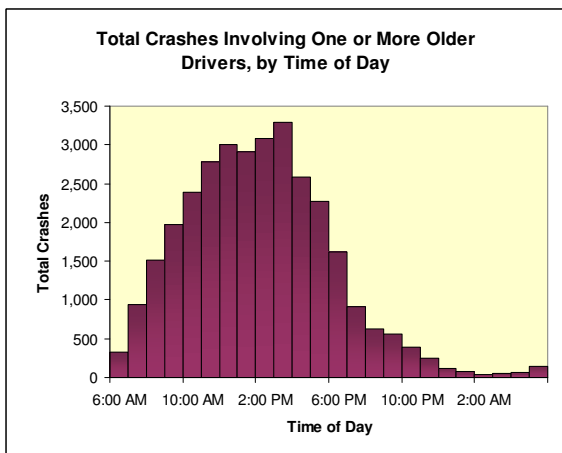
- 44.5% of crashes involving older drivers took place in Cook County
 - In comparison, Cook County accounts for just 27.4% of the overall population of Illinois aged 70 and above** and just 31.8% of the average vehicle miles traveled in Illinois††
- 88.5% of crashes involving older drivers took place on roads or highways that were classified as "urban" use, compared with 86.8% of other crashes

Time of Day

- 29,279 (91.7%) of all 31,940 crashes involving one or more older drivers occurred between 7:00 am and 7:00 pm.**
- In comparison, 297,368 (73.8%) of all 402,757 crashes involving no older drivers occurred between 7:00 am and 7:00 pm.††
- Overall, 31,979 (7.3%) of all 437,289 crashes that occurred in Illinois in 2003 involved one or more older drivers, but that rate varied by time of day. †††
 - The highest involvement rate for older drivers was between 11:00 am and 12:00 pm, when 2,393 (13.9%) of all 17,199 crashes involved one or more older drivers. †††
 - The lowest involvement rate for older drivers was between 2:00 am and 3:00 am, when 43 (0.7%) of all 6,564 crashes involved one or more older drivers. †††
